Terms and Conditions

- 1. Exclusive rights** - It is understood Krystle Clear Productions is the exclusive official Photographer and/or videographer retained to perform the services requested on this contract.
- 2. Delivery** - No part of any order will be delivered until balance is paid in full.
- 3. Usage** - Krystle Clear Productions reserves the right to use Photos and/or videos for display, publication or other purposes. Photo / Video masters remain the exclusive property of Krystle Clear Productions.
- 4. Postponement / Cancellation** - In the event of a postponement or cancellation of the affair/ contract, the retainer and deposits paid are not refundable. The Client shall be responsible for paying the full balance, if he/she cancels the scheduled services without giving Krystle Clear Productions a minimum twelve weeks written notice prior to affair date. Such notice must be delivered to Krystle Clear Productions via certified or registered mail.
- 5. Studio liability** - Krystle Clear Productions takes the utmost care with respect to the post production editing and delivery of the video(s). However, in the event Krystle Clear Productions fails to comply with the terms of this contract, due to any event or act outside the control of the studio, Krystle Clear Productions's liability is limited to the refund of the deposits paid.
- 6. Assigns / Substitutions** - In the event of illness or any reason outside the control of Krystle Clear Productions, Krystle Clear Productions reserves the right to substitute the photographers and/or videographers assigned.
- 7. Additional charges** - If something occurred at the event that the client does not want to appear on the videotape or photographs, the Client must instruct the studio before editing begins. Editing done after the video has been delivered to the Client, will be charged for re-editing at current rate of \$100.00 per hour for editing and labor.
- 8. Out of state residency** - In the event the Photo(s) and/or video(s) are sent out of the state of New Jersey, the minimum order must be paid in full before the photo(s) and/ or video(s) can be delivered.
- 9. Warranties** - Krystle Clear Productions makes no warranties express or implied, with respect to the work or property that is the subject matter of this contract.
- 10. Additional invoices** - The Client shall be responsible for all additional items ordered above this contract. The terms and conditions of this contract shall be applied to all additional invoices associated with this contract.
- 11. Production & Editorial Control** - Krystle Clear Productions is granted full production and editorial control by the client regarding all aspects of the production and post-production services for this event. In the case a particular segment of the event is either not recorded, partially recorded, or not part of the edited master tape, it is at the sole discretion of Krystle Clear Productions as the exclusive producer of the event photography and/or video recording.
- 12. Production materials** - Client video production materials such as photos, music, etc. are due within 30 days after the event. If the materials are not supplied by the due date, Krystle Clear Productions reserves the right to exclude the segments from the finished video.
- 13. Meal provisions** - If you have booked a Krystle Clear Productions photographer and/or videographer for more than five(5) hours, we ask that a courtesy meal be provided for him/her. If a meal is not going to be provided, then the videographer may have to leave your reception for 1/2 hour to 45 minutes. (Please let us know if the latter is the case so they can plan ahead).
